Furthermore, members have the privilege to participate in a broad range of auxiliaries, such as STARFLEET Marines, Medical, Sciences, Petfleet, and more, allowing them to explore various aspects of the Star Trek universe and engage with like-minded enthusiasts.



> Here aboard the USS Veritas, we value transparency and accountability in our leadership structure. The appointment of the Commanding Officer (CO) and Executive Officer (XO) is determined by a democratic vote among our ship's full members.

To address concerns and align leadership with our organization's values, any ship member can initiate a vote of no confidence for the CO and/or XO. This motion requires a minimum of 66% + 1 vote to pass. If successful, elections for a new CO and/or XO will follow.

Upon electing the ship's new leadership, a two-week transition period begins. During this time, the outgoing leadership facilitates the smooth transfer of accesses, email and social media page credentials, if applicable, to the newly elected CO and/or XO. This ensures a seamless and peaceful transition of responsibilities.

After the 14-day transition, the newly elected CO and/or XO officially assume their roles, bringing fresh perspectives to the USS Veritas's leadership. This process reflects our commitment to responsive governance and ensures our organization can adapt and thrive under leaders who represent the collective voice of our dedicated members.



Membership Away Missions

In the exploration of uncharted territories and encounters with new civilizations, STARFLEET crews often find themselves engaged in "away missions". These excursions are essential for gathering valuable data, establishing diplomatic relations, and addressing unforeseen challenges.

Within the scope of our chapter, an "away mission" is defined as crew members taking time off for various reasons, including vacation, attending conventions, participating in events, and more. Moreover, these away missions may encompass collective participation in events like Comic-Con, which our chapter attends together when feasible. It is worth noting, however, that attendance is not obligatory due to the considerable distances involved.

Before embarking on an away mission, crew members are encouraged to formally request a shuttlecraft. This request should include the purpose of the mission, the number of personnel involved, and any specific equipment or resources needed.

Bridge Officers

- 2. The next steps involve completing the Officer Training School (OTS) course,
- followed by the Officer Command Course (OCC). It's also advisable for officers to take the STARFLEET Data Protection Policy (SFDPP) courses
- Finally take the Bridge Officer Certification Programming for their department.

These courses, accessible through STARFLEET Academy, greatly contribute to enhancing your understanding of your role within the department.

03:20.1 - Commanding Officer (CO)

The Commanding Officer (referred to as Captain or CO) oversees the daily operations of the USS Veritas. Serving as the principal spokesperson, they are responsible for maintaining order, upholding the chapter's functionality, and ensuring adherence to STARFLEET International policies and directives. The Commanding Officer (CO) interprets and ensures compliance with both STARFLEET International and diplomatic guidelines. The primary responsibility of overseeing Monthly Reports (MSR) falls under their purview, and the Commanding Officer (CO) is answerable to STARFLEET International for the overall performance of the chapter.

In embodying the principles of Star Trek, the Commanding Officer (CO) cultivates an environment characterized by optimism, openness, and a sense of belonging. The mission of the USS Veritas is to serve respective communities through charitable work and to cultivate an environment of goodwill and camaraderie.

Section 03:20.2 - Executive Officer (XO)

The Executive Officer (referred to as XO or First Officer) serves as the Commanding Officer's right-hand on the USS Veritas. Entrusted with executing directives and assuming the same responsibilities as the Commanding Officer in their absence, the Executive Officer (XO) manages records pertinent to the chapter, ensuring a comprehensive archive of the ship's activities. Beyond administrative duties, the Executive Officer (XO) actively engages with the crew, particularly new members and Department Chiefs, fostering a collaborative environment within the ship that reflects the principles of unity and camaraderie inherent in Star Trek.

In addition to their mentoring role, the Executive Officer (XO) carries the responsibility of overseeing internal investigations. Demonstrating a commitment to impartiality and diligence, the Executive Officer (XO) navigates challenges within the ship, contributing to both operational efficiency and the communal spirit that characterizes the USS Veritas.



Section 03:20.3 - Second Officer and Helms

The Second Officer on the USS Veritas holds the third-highest rank on the starship and is designated to assume command in the absence of both the Commanding Officer (CO) and Executive Officer (XO). In the event that the current Executive Officer (CO) becomes the Acting Captain, the Second Officer can step into the role of First Officer.

The primary responsibilities of the Second Officer on the USS Veritas encompass ship navigation and maintenance. Functioning as the Chief Helm Officer, they are responsible for steering the ship and ensuring its smooth operation, particularly during emergency situations (with a stipulation against performing barrel rolls).

Section 03:20.4 - Chief of Communications

The Chief of Communications plays a crucial role in maintaining seamless communication within our crew and STARFLEET International Auxiliaries. Tasked with the sharing of information to crewmates, they report directly to the captain.

In addition to these responsibilities, this role oversees the Chapter's Newsletter team, taking the lead in its production and distribution. The creative flair applied to newsletters is essential for keeping the crew well-informed and fostering unity among ship members. The commitment to effective communication significantly contributes to the ongoing mission of the USS Veritas.

Section 03:20.5 - Chief of Intelligence

The primary responsibility of the Chief of Intelligence is gathering information on upcoming event and convention opportunities. They will report finding to the Chief of Communications to ensure the crew is made aware of opportunities in the local and regional level.

All crew members under the age of 18 will to assigned as Cadets except as specified below.

Cadets ages 14 or older may request to "graduate early" and be recognized with full Enlisted or Commissioned rank, along with the responsibilities inherent with the role. Such advancement of crew members under the age of 18 will not be allowed to advance beyond the rank of E-4 or O-4 until the crew members 18th birthday.

Cadets that achieve the rank of Cadet Crewman before they "graduate" may upon enlistment or commission will be advanced ahead of peers by two grades for enlisted or one grade for officer so long as all other requirements are meet. (i.e. Crewman E-3 / Lieutenant Junior Grade O-2)

To be commissioned must have completed OTS. Enlisted in the grade of E-5 or higher that commission are eligible to be commissioned at the Rank/Grade of Lieutenant Junior Grade/O-2. Promotions for Grades O-1 (Ensign) through O-5 (Commander) are authorized to be approved by the Commanding Officer of the ship (Chapter). The Grade of O-6 (Captain) is recommended for approval by the Ship's Commanding Officer, and approved at the Region level by the Regional Coordinator. Approval at this level usually require participation and/or service at the regional level. Grades of O-7 and above must be approved by the Executive Committee of STARFLEET. This process requires a promotion packet and participation and/or service at the fleet level.

Promotions TIG Waivers & Field Promotions

Time In Grade Waivers

Time in Grade (TIG) requirements may be reduced by half for exceptional performance. Approval of Time in Grade waivers are at the discretion of the CO or his delegated representative. These waivers may be requested by a Department Head, OIC, Team Leader, Auxiliary representative, Regional Coordinator, Executive Committee member, or the Chain of Command.

Field Promotions

It is possible to be promoted specific ranks directly by virtue of positions held. This can be anything from a Department Head on the ship to becoming Commander of STARFLEET itself. Additionally, individuals who serve on fleet level committees (i.e. VIC positions, IC committee, etc.) for a period of 6 moths or greater can be promoted. Such promotions are provisional until a trial period of time elapses in which the rank becomes permanent.





Promotions Promotion Points

There are many ways to earn promotion points, but they all boil down to one thing, Participation!

There are two types of promotion points you can earn;

Regular that reset each time you achieve a new rank/grade, and Permanent that do not reset and follow you through your STARFLEET career.

Permanent points are hard to earn but can well be worth the effort.

All regular promotion points marked with * and earned while in uniform at in person events are doubled for the event in question. Below is an extensive, but not all-inclusive list of ways to earn promotion points. If you want to know if something can count for points, just ask.



Uniforms Departments & Colors

In alignment with the design theme of the USS Veritas and the period of our service, we have chosen to introduce an optional standardized dress code for the Chapter. Commencing our ship's mission in 2378, the year of the return of the USS Voyager to the Alpha Quadrant, members retain the freedom to wear any uniform of their preference. However, we encourage, though not mandatory, a unified look for significant events, as it has a more impactful effect.

The recommended uniform for the Crew of the USS Veritas during chapter outings and conferences is the DS9/First Contact Uniform, dating back to the early-2370s.



Starfleet has largely used three colors to distinguish the three main divisions in the service — gold, blue, and red.

Command officers include the Captain, Executive Officer, Yeoman, Helm, and Intelligence.

Operations officers included Engineers, Security, Operations, Communications, and Tactical.

This division is the corps of members within STARFLEET who specialize in both scientific and medical research (including the ship's counselor).


